FSC Forest Management Training

FSC require all auditor candidates intending to qualify as auditors against FSC's Forest Management scope to complete formal FSC Generic training and Forest Management Training.

The course is provided as blended training with e-learning content and 'audit real' in-person training covering the following:

- Structures and relationships within the FSC system relating to its main stakeholders (members, ASI, FSC, regional and national offices, certificate holders, license holders and certification bodies)
- FSC and other forestry certification schemes
- Roles and responsibilities in certification according to FSC's normative documents
- Potential effects and impacts of certification
- Overview of FSC's normative system and its structure
- The FSC dispute resolution management system
- FSC and timber legality legislation
- Conflict of interest definitions and requirements

Forest Management

- Overview of general requirements for FM application (quality management system, scope etc)
- National and interim national standards and the role of the international generic indicators (IGI's)
- FSC's stakeholder consultation process and its application
- The FM certification process and certification decision making
- Group certification of FM
- Certification of small and low-intensity managed forest
- Social requirements within certification
- Legal and customary rights of indigenous peoples, as addressed in the UN Declaration on the Rights of Indigenous Peoples, national laws and indigenous laws

The e-learning takes 18-24 hours and the in-person training, including final assessment, is scheduled over 4 days.
