







Transaction Certificate Request Form

Guidance notes for completing this form

Buyers of textile products certified to Global Organic Textile Standard (GOTS) or Textile Exchange Organic Claim Standard (OCS), schemes will require a Transaction Certificate (TC) for each consignment purchased. We will generate Transaction Certificates for you within 15 working days after receipt of a complete application form, provided we have enough detail about the goods and their origins. Complete the form below and attach all necessary documents and evidence and return it to your certification officer.

References are included to the where the information will appear on the transaction certificate once issued.

Please note, we are not required to issue TCs more than six months after the date of the earliest shipment to be included. References are included to the where the information will appear on the transaction certificate once issued.
